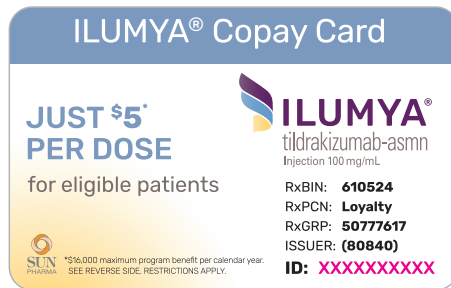

ILUMYA® EARLY ACCESS PROGRAM

If you have commercial insurance, you will be automatically enrolled in this program and are eligible to receive ILUMYA® (tildrakizumab-asmn) for free for up to 2 years.*

ILUMYA® COPAY PROGRAM

With the ILUMYA® Copay Card, eligible patients with commercial insurance may pay no more than \$5† per dose.

ILUMYA® PATIENT ASSISTANCE PROGRAM

If you do not have enough insurance coverage or do not have insurance at all, you may be eligible to receive ILUMYA® at no cost through the Patient Assistance Program. Income documentation is required. Subject to terms and conditions.

MEDICARE PART B

Because ILUMYA® is a biologic medicine that is injected in the office by a medical professional, it is covered by Medicare Part B as a medical benefit. Most people with Medicare Part B coverage could pay \$0 for ILUMYA®.‡

*Eligibility rules apply. Patients must be commercially insured. For patients to remain eligible for the Early Access Program, providers must submit a medical and/or pharmacy prior authorization form before a patient's third dose.
